1. Any permission granted to the Photographer shall extend to his/her successors, legal representatives, licensees and assigns and shall be irrevocable and perpetual without any further or additional claim for compensation by either the Client or the Parent/Guardian.
2. Permission is specifically granted for the Work to be edited, altered, distorted, used in whole or in part, in conjunction with other images, graphics, text and sound in any way whatsoever and without restrictions.
3. Permission herein granted is absolute and final and shall not be subject to further inspection or approval by either the Client or Parent/Guardian at any stage in the use of the Work.
4. Use of the Work shall be unrestricted as to location, quantity or frequency, may be for any purpose and in any medium whatsoever, whether foreseen or unforeseen at this time, except where such use is in contravention of the law.

5. You hereby grant to Grads on the Go Photo Studio the right to use and publish images and photographs/videos taken at your photography session to further promote its service, including portfolio, web site, social media, display, advertisement, and editorial use, unless otherwise discussed beforehand. Grads on the Go Photo Studio agrees to limit the use of these images and photographs to promotional use only. Grads on the Go Photo Studio may revoke this license at any time and for any reason. Grads on the Go Photo Studio retains all copyrights to the images and derivative works thereof.

By using any of these images, you are agreeing to the above terms.

6. The Photographer shall own all rights in the Work which shall accrue to the benefit of his/her successors, legal representatives and assigns. I acknowledge that since my participation with Grads on the Go Photo Studio is voluntary; I will receive no financial compensation.

7. The Client (or Parent/Guardian) warrants having read and understood this Photography Release Agreement, and being of legal age and competency and with every right to enter into an agreement on behalf of themselves (and/or the Minor).

8. With full knowledge of the above, the Client (Parent/Guardian acting on behalf of the Minor where applicable) hereby releases and shall hold harmless the Photographer and his/her successors, legal representatives, licensees and assigns from all claims or damages including but not limited to defamation or violation of right of privacy or publicity, resulting from or associated with the use of the Work.

9. The Client (Parent/Guardian) agrees that the provisions contained herein shall be binding upon the Client (Parent/Guardian and Minor) as well as their collective successors, legal representatives and assigns.

10. This Agreement shall be construed, interpreted and governed in accordance with the laws of the Province of Manitoba and should any provision of this Agreement be judged by an appropriate court as invalid, it shall not affect any of the remaining provisions whatsoever.

11. No refunds will be granted as our packages are digital in nature and the poses captured will be reviewed by the client with the photographer prior to the end of session.
